A. ITEMS OPENING MEETING:

1. CALL TO ORDER:

C. GENERAL BUSINESS AND ACTION ITEMS:

1. Update from Ann DaPrato, Parks & Recreation Coordinator on park improvements and plans.

Ms. DaPrato presented a detailed report of the existing and the proposed improvements for the parks and budget.

Ms. DaPrato reported that the survey for Shady Park has been completed. The volleyball court in JB's Park has been completed. Irrigation projects and lighting in JB's and Shady Park was covered. JT Street Fest and 5K run was discussed. Movie title options and licensing were covered. Upcoming Trunk or Treat was briefly discussed by members.

2. Discussion and possible action on the proposed park budget recommendations to the City Council for the 2022-2023 fiscal year.

Ms. DaPrato provided and reviewed the proposed park budget for the 2022-2023 Fiscal Year. The lowering of the Park budget from \$75,000 to \$13,300 was covered. Member O'Brien

announced she will be giving a special presentation to a JT meeting in the morning at 0830, to persuade the need to reestablish funds to the Park budget.

3. Discussion and possible action on the proposed park events for 2022-2023 fiscal year.

Member O'Brien proposed to move \$2700 from Easter event and move to Fall Fest. Seconded by Chair Lopez and passed unanimously by all members.

Member O'Brien proposed a vote to approve the revised and prioritized Park & Recreation Budget for 2022-2033 as presented by Colleen O'Brien. Seconded by Member Dansby, passed unanimously by all members.

A motion was made by Chairman Latos and seconded by Vice Chair Buckley to adjourn the meeting. The motion passed unanimously. Meeting adjourned by Chairman Latos at 8:25 p.m.
